## 2006 Facts

- Number of full service members – 7,810
- Cost to youth to be a Club member – \$2.00 per year
- Average number of hours spent in Club per visit – 3.3 during the school year; 4.56 during the summer
- Total hours of service provided – 617,077
- Average number of meals served to Club members each day – 486
- Percentage of members whose families live in poverty (family income less than \$25,000) – 75%

## 2006 Major Accomplishments

- In 2006, 617,077 hours of direct service were provided to the 7,810 members in Club programs at our six metro-Denver clubs. This past year we saw an 8.52% increase in our Club membership.
- 1,814 volunteers performed 25,882 hours of volunteer service at the Boys & Girls Clubs of Metro Denver. This translates to a \$466,902.26 value for the organization!
- Larisa Harvey, BGCMD's 2006 Youth of the Year, was the introductory speaker at the Helping America's Youth Regional Conference. The conference, held at Denver University, was part of a national project initiated by President and Mrs. Bush to raise awareness about the challenges facing youth. Larisa spoke about being a role model and the adults that have influenced her life.

- Four Club members were awarded \$2,000 college scholarships from the Charles Schwab Foundation after completing the Money Matters financial literacy program which teaches teens how to make responsible financial decisions.
- BGCMD received Boys & Girls Clubs of America's National Honor Award for Program Excellence in the area of Sports, Fitness and Recreation for the creation and implementation of the Outdoor Adventure Club at the Denver Broncos Boys & Girls Club.
- The Board of Directors began a comprehensive strategic planning process which will provide a road map for the future of the organization.
- BGCMD had 11 of 39 regional winners in the 2006 Southwest Fine Arts Exhibit. These pieces advanced to the national exhibit.
- Two members of the Johnson Branch had poems published in the book *Making One Good World: Kids Write About Diversity*. This book is a compilation of pieces written by members expressing their thoughts, experiences and feelings regarding diversity.
- BGCMD partnered with more than 75 organizations last year to provide quality programming to our members.

- Nesa Hassanein, Executive Vice President and General Counsel with The Sports Authority, and Mark Evans, Assistant Vice President of Qwest Communications, were named to the Board of Directors.
- Former BGCMD CEO, John Arigoni, accepted a position at the Boys & Girls Clubs of America as the Senior Vice-President of Strategic Planning. Tim Sheahan, a 34-year Boys & Girls Clubs veteran, was named President and CEO of Boys & Girls Clubs of Metro Denver in September. Kathy Luna, a 27-year employee of BGCMD and former Vice President of Development, was named Chief Operating Officer.
- BGCMD increased its corporate volunteer outreach program resulting in approximately 38 corporations volunteering over 3,285 hours of volunteer service in 2006. One particular event brought together employees from dozens of companies including Opus Northwest, Fuller Real Estate, Ultimate Electronics, Home Depot, Best Buy, Americorps NCCC and Verizon to install a new playground at the Arthur E. Johnson branch.

- BGCMD received the 2006 Southwest Youth for Unity Gold Award for Words Can Heal, an anti-bullying program.
- BGCMD had 6 regional winners and 1 national winner in the ImageMakers Photography Contest.

- The Accelerated Reader program was implemented in all six Clubs during the summer of 2006. The program was designed to help Club members retain reading skills during the summer when reading levels typically decline. At program end, 578 youth had read 9,294 books. 61% of participants increased their reading level.







## The Jeremiah Milbank Society

The Jeremiah Milbank Society is a national recognition group created to recognize individual donors and families who support local Boys & Girls Clubs with annual unrestricted gifts of \$10,000 or more.

Jeremiah Milbank (1887 – 1972) was a man of remarkable accomplishments as a businessman, financier and philanthropist. A lifelong believer in volunteerism, Jeremiah Milbank helped President Herbert Hoover develop the Boys & Girls Club national organization that provides support services for Clubs serving disadvantaged youth. He served as treasurer of the national organization for more than 25 years.

Throughout his lifetime, Milbank gave a fortune to help those in need. His truest legacy has been his children, and their children, who continue to support causes that were close to his heart. His extraordinary and life-long concern for youth and those less fortunate has changed the lives of millions and is the inspiration for The Jeremiah Milbank Society.
