2017 HIGHLIGHTS

More than 275,000 meals were served at the Clubs this past year with support from partners like Food Bank of the Rockies.

Boys & Girls Clubs of America
has recognized BGCMD as one
of the best Club art programs in
the nation. This past year,
four BGCMD Club members
were selected as National Fine
Arts and Digital Arts winners.

We piloted a new literacy instruction program focused on helping struggling readers. 94% of program participants showed improvement in all foundational reading skill areas.

Karol Martinez, from the

as the 2017 Boys & Girls
Club City Youth of the Year.
She went on to compete and
win the title of the Colorado
State Youth of the Year. She
was awarded scholarships,
including the Daniels
Fund Scholarship, for her







- Over **2,200 Club** members participated in team sports at the Clubs


